#### **RESUME OF MINUTES:**

Confirmation of Legal Notification: Yes, per Clerk Halley.

President Bloohm called the meeting to order at 6:00 p.m. Roll call was taken. The pledge of allegiance was recited.

PUBLIC COMMENT: No written or oral comments were received.

Springfield Solar Farm: Attorney Mark Hazelbaker of the Kasieta Legal Group spoke to the Board about what is feasible and possible for Village opposition of the Springfield Solar Farm. The Board was in consensus to allow the Kasieta Legal Group to speak on the Village of Brownsville's behalf concerning the Springfield Solar Farm, with Trustee Dr. John F. Pesch, Jr. designated as the contact person for the Kasieta Legal Group. The cost for this service not to exceed the \$3,000.00 cap approved at the Sept. 9, 2020 Regular Board Meeting.

The Board took no action on a request to reverse the Boards decision to cancel Halloween Trick or Treating in the Village.

Motion by Trustee Kemmel, second by Trustee Dineen, to allow rental of the Brownsville Community Center to the Brownsville Fire Co., Inc. at a fee of \$100.00, on November 13, 2020; motion carried. 4-aye 1-nay(Pesch)

Motion by Trustee Pesch, second Trustee Westphal, to grant a Temporary Class"B"/"Class B" Retailer's License to the Brownsville Fire Company Inc. for a November 13, 2020 fundraising event at the Brownsville Community Center 871 Main St., cost of the license \$3.00; motion carried. 5-aye

Motion by Trustee Westphal, second by Trustee Kemmel, to accept the 2021 Fire Protection Contract with the Brownsville Fire Company, Inc. at a cost of \$24,000; motion carried. 5-aye

Rental of the Brownsville Community Center was discussed.

No action was taken on "park player fees" for the Brownsville Athletic Association.

Trustee Dineen informed the Board of the successful season for the North District Flyway Soccer Association.

Motion by Trustee Pesch, second by Trustee Dineen, to approve the Joint Powers Agreement, County 911 Emergency System with Dodge County; motion carried. 5-aye President Bloohm signed the Agreement.

Motion by Trustee Pesch, second by Trustee Kemmel, to not enter into an agreement with the Dodge County Humane Society; motion carried. 5-aye

Motion by Trustee Pesch, second by Trustee Kemmel, to approve an Operator's License for Katie A. Wieting, for the year ending June 30, 2021; motion carried. 5-aye

Election day security was discussed.

Storage in residential rear yards was discussed, including possible reversion of existing ordinance.

The future of the Brownsville Police Dept. was discussed

Motion by Trustee Pesch, second by Trustee Westphal, to increase sewer rates by 3% January, 1, 2021; motion carried. 5-aye

A ball diamond fence was damaged by a vehicle at the Dale R. Michels Memorial Park. An insurance claim has been made for the damage.

Motion by Trustee Pesch, second by Trustee Westphal, to offer a \$100.00 reward for information leading to an arrest and conviction of those responsible for damage to trees on Village of Brownsville public property; motion carried. 5-aye

The Board received information on the reissuance of WPDES Permit, Wastewater Treatment Facility, No. WI-0021601.

The Board reviewed information on the DNR Approval of Plans and Specifications for the Chemical Phosphorus Removal Feed Upgrade.

Motion by Trustee Pesch, second by Trustee Dineen, to accept and transfer the Local Road Improvement Program grant monies of \$45,213.69 to the Village of Brownsville Street Repair Account from general checking; motion carried. 5-aye
