### VILLAGE OF BROWNSVILLE POLICE DEPARTMENT 2023 ANNUAL REPORT

With how the world is changing these days, for the better and unfortunately for the worse, the Brownsville Police Department acknowledged how important it was to build a strong relationship and partnership with its community; especially a unique community like ours. Standing behind this philosophy, it certainly ensured the safety of the Village and enhanced the quality of life for its residents, businesses, those who visit, work and travel through the Village of Brownsville.

Looking back in 2023, the residents of Brownsville were extremely fortunate that very few significant crimes had occurred in the Village of Brownsville, compared to surrounding areas in Dodge County. This was due to several factors, such as the Village residents being security conscious and with the efforts of the Police Department being highly visible. Nonetheless, the Brownsville Police Department had taken a proactive approach towards law enforcement, with the goal of obtaining voluntary compliance with the law.

It should be noted, the Brownsville Police Department continued to work jointly, when appropriate, with other agencies in Dodge County. The Brownsville Police Department was provided additional resources which benefited the residents of Brownsville. The Brownsville Police Department provided mutual aid or assistance to the Dodge County Sheriff's Department, Theresa Police Department, and the Brownsville Fire Company First Responders. During EMS calls for service, the Brownsville Police Department was able to arrive within one to three minutes, while on duty, to begin assessment of the patient and start treatment as necessary.

Since 2016, the Brownsville Police Department has been a member of the Standard Mutual Aid Response Team (SMART) agreement, which includes all police agencies in Dodge County. The purpose of this agreement is to provide law enforcement agencies with either personnel and equipment during times of emergencies. SMART can be activated during situations that potentially threaten or cause loss of life, property or during situations that exceed the physical and organizational capabilities of a law enforcement agency. For example, during severe storms, floods, HAZMAT, major crimes, barricaded subjects, hostage situations, traffic control or similar occurrences.

It should be noted that I was selected as a member of the highly decorated Dodge County Multi-Jurisdictional SWAT Team, after a vigorous selection process. The Dodge County Multi-Jurisdictional SWAT Team is provided with higher standards of training and equipment for low frequency/high-risk callouts. This advanced training provided by the Dodge County Sheriff's Office accounted towards the mandatory 24-hour training each law enforcement officer must participate in each year to stay certified by the Department of Justice Training and Standards Bureau.

The Brownsville Police Department takes pride in attending special events throughout the year, which included: soccer and baseball practices, games, Trick or Treating, Turkey Trot, Theresa National Night Out, Fox Lake Cops 'n Bobbers and the 21st Anniversary Shop with a Cop Holiday Event in Beaver Dam. During the 21st Anniversary Shop with a Cop Holiday Event, children that are in need were gifted with \$150.00 to spend on their families for Christmas. This year, the child I was paired with purchased a new hammer for his father, had gifted his mother with new art supplies, and surprised his brother with new toys. During the Turkey Trot event, I ran in full uniform and the next day I was sore.

The charts below are a breakdown of hours worked and contacts made throughout the year. There were 921 cases generated, some of which included but not limited to: 288 traffic stops, 28 mutual aid requests, and 209 grievances. Some grievances included disorderly conduct, suicidal ideations, trespass, and fraud cases. Even though the prison was on lockdown for part of the year, due to COVID and staffing shortages, there was still an increase in traffic stops from last year. Most of the traffic stops were simply initiated from speed violations, including 60+mph in a 30mph posted speed limit. Some of these traffic stops evolved into locating drugs, drivers operating while suspended or revoked or not even licensed.

Some administrative duties that I completed throughout the year included writing reports, completing open record requests, adopting new policies and procedures, attending meetings, submitting monthly documentation to the Wisconsin Department of Justice. Some documentation that was submitted to the Wisconsin Department of Justice included: Wisconsin Incident-Based Reporting System (WIBRS), Use of Force and Arrest Related Death (UFAD) and training attended throughout the year through ACADIS. Some training included the New Chiefs Conference and Basic SWAT. It should be noted, all training/room and board attended this year was free.
