

Keep food and liquid out of your recycling.





Please space your garbage and recycling carts 3 feet apart, with the front of the cart facing the street. This helps the automated trucks not knock over the carts.

All garbage and recyclables need to be placed into the carts, including cardboard.

DOG LICENSE

WI State Statutes 174.07 requires a dog license for the keeping of a dog over 5 months of age. Dog Licenses expire December 31. If you previously licensed a dog you no longer own, please let the clerk know.

To avoid a late fee, licenses must be obtained by April 1. Late Fees of \$5.00 per Dog apply after April 1. Additional penalties may apply for failure to license a dog.

Attach copy of current certificate of rabies vaccination, valid proof of rabies vaccination includes the rabies manufacturer, serial number, date the vaccination was given and date the vaccination expires.

Drop this information off with applicable fees at the Village Clerk's Office 871 Main St., during clerk posted hours or in the door slot (available 24/7 through south doors) after hours. The information and payment may also be mailed: Village of Brownsville, PO Box 308, Brownsville WI 53006.
